Ward and the cartel Capitalize on victims

Most of these cartel members are SOCIOPATHS

Hulleberg was a victim of his abuser dad.

1975 When I was 15, his Family joined the church.
 Father Bjorn Sr., Mother Regina, Bjorn Jr., Regina and
 Brian. I knew then that the girl smelled of urine
 because she was probably being raped by "someone."

I would be told by Hulleberg, that is exactly what
 happened. All of the children were abused sexually. No
 one in the church or police stopped it. People at
 church knew.

1980s Hulleberg was a Boy Scout and Jack Ward was the
 Scoutmaster. I believe this is where Ward GROOMED him.
 Ward is CIA as was his father-in-law. Using people for
 targeting, spying and financial frauds is what they do.

1985-88 My family won Judgment against church leaders.

Gordon & David Hall DEFRAUD us in two video stores. Gordon was Bishopric, David Stake High Counselor. Two Mormon Mafia cartel members were picks of Ward. I approached the Mormon Bishop for RELIEF;

Bishop John Clawson said, "Sue them!"

We did and won.

I went back. "Nothing I can do now."

I approached the Stake President.

Brent Horsley said, "I've lost money, too."

But we DIDN'T lose it, we were DEFRAUDED.

1988 Hulleberg's Mother Regina died. She was a good woman, who was abused by her brothers growing up. She died within a couple months of diagnosed with CANCER.

I helped him with funeral arrangements. The kids received a small death insurance benefit. Hulleberg went to live with my parents for a couple months before leaving on a Mormon Mission.

During those few months, my sister reported for years, how Hulleberg would peer through the bedroom door at her, knowing she could see him back.

Son Brian, who was under 18, went to live with the FRUAD ARTIST Gordon Hall, and they moved to Salt Lake City. I got the impression Brother David regretted what his brother got him into. We were PAID ONLY Attorney Tom Green's fees and costs.

Gordon Hall was the Chief Financial Officer of St. Anthony Hospital. He went to work for Rochelle Community Hospital, but he allegedly misappropriated some funds there also.

All the while PROTECTED from prosecution of Criminal Penalties. Attorney Jack Ward's foremost colleague of the court was Judge/States Attorney Paul Logli, who BOTH joined the local bar, 1978, the years Ward and Meyer lured me into their web.

Ward was Hulleberg's Scoutmaster in his teens.

Logli used to come to the Court of Honors. I went a couple of times to see Logli, representing Good, Virtue and Moral Authority. As a journalist, Logli had me arrested for covering the allegations of a teenage foster-girl raped by Logli's lunch-mate, who was the Chief Judge of the Circuit Court—who RESIGNED Nov. 1996

Logli had me arrested with a Federal Marshall and Sheriff's Deputy, who threatened me with beating as they traipsed me past a political prisoner, whose WIFE was the victim RAPED. They asked me, "You know who he is!" Inferred, are you going to cover that story anymore?

After a dozen more FEMALE "SURVIVORS" of the pedophilia came to me as Assistant Editor, I learned the "pillars of the community" are secretly bound together by oaths of child abuse, pedophilia and even child sacrifice, orchestrated through infiltrators in the FBI and CIA. It's INTERNATIONAL.

Human trafficking is more lucrative for profits than drug smuggling. The Mormon Mafia's local agents are involved 100-percent in drug trafficking. And from half a dozen WITNESSES and PROFESSIONALS, the local Rockford Mormons, Democrats and Republican are involved with CHILD ABUSE and CHILD TRAFFICKING.

This is the most shocking thing we learned at The Rock River Times with the staff and Publisher Frank Schier. Mayor Morrissey showed him were the Satanic meetings were being held, used to be. I'm not saying Morrissey is a Satanist, but he did WITHHOLD the evidence when he was my Lawyer, costing me \$500K.

I believe Ward GROOMED Hulleberg while he was his Scoutmaster. A 12-year-old boy, whose father abuses him, is going to NEED a mentor like Ward. But Ward was going to CAPITALIZE on Hulleberg's SECRETS, and I believe that is the bottom-line of BLACKMAIL which binds Hulleberg to Ward.

Although Hulleberg IS the face of the local cartel, I don't believe HE WOULD BE PART OF DEFRAUDING me, if not for Ward's manipulation of Hulleberg's past.

Ward, the Church and law enforcement had a CHOICE, to do what is right and get the Father Senior TREATMENT or PENALTY, or make the WRONG CHOICE, let the daughter be raped, sons, too. Then, I believe people like Ward CAPITALIZE on the Dark Side of the Dark Ages, that is secretly used as the Oaths and GLUE that binds these SOCIOPATHS, who COVET to LORD over people.

The secret Mormon Mafia in Rockford is run by BANKERS. Ward and son Brent are the two I know of. Their partners are not Mormons. Because of Wards PEDIGREE to Oaks, an APOSTLE, U.S. Supreme Court Nominee TWICE, Utah Supreme Court Judge, left the back-door open at Watergate for Bush to remove Nixon for STOPPING the military industrial complex's Vietnam War profits.

Oaks is on the Board of Directors of Union Pacific Railroad, same as Brigham Young, E.H. Harriman, Rockefellers, Mormon Fed. Chairman Marriner Stoddard Eccles, his Assistant David M. Kennedy, who INTRODUCED HEROIN to America in 1959 Chicago with Continental Bank and the Vatican.

They got caught in 1974 and I SEE that the Chicago Democrat Harriman-Rockefeller cartel moved a leg to Rockford under the direction of G.H.W. Bush, Oaks, Bill Clinton from Mena, Arkansas, Little Rock, Rockford and Chicago—using the Chicago Machine Game Book.

1978 I was targeted when they set up Concord Commons with Ward, Meyer, Amcore Bank, Accountant Bruno, unions and a murder in a building by Atty. Meyer's clients/partners.

1986 A PIZZA SHOP in Oregon, Illinois, pop. 3,700, was BUSTED smuggling \$1.6B in heroin in pizza boxes, picked up by Chicago Mob vendors. The operation became known as "The Pizza Connection" and run from Sicily, by the Italian Mafia "Don" Gaetano Badalamenti.

One of the Good FBI was a Mormon and he told me at church about things when they were over. His partner used to come into our video store. He got shot in the face. That's how ONE KNOWS they were the GOOD GUYS.

Hulleberg befriended me at that video store, who would take his breaks from his job at "Union Hall," a department store.

Hulleberg is USED as a 'PROXY'

Hulleberg is a VICTIM of his father and WARD. But HE IS A PERPETRATOR of FRAUD to me. I don't know Ward's childhood in Chicago, to know if he was also abused, or if it was just his GREED and PEDIGREED Wife?

This is one of the biggest reasons to INVESTIGATE and stop the what is a breeding ground for SOCIOPATHIC BEHAVIOR.

Hulleberg's father was a KNOWN PEDOPHILE at the Rockford First Ward congregation, since the mid-1970s, in the building my Parents moved from Minneapolis to build in 1959, the same year our Chicago Mormon Leader and Chairman of Chicago's Continental Bank INTRODUCED HEROIN to America with his partner Vatican Bank Treasurer Paul Marcinkus, who was Archbishop of Chicago.

Hulleberg began targeting me just before his mother died when he was 18.

Hulleberg is a Victim/Perpetrator. His father was an abuser but NO ONE IN THE CHURCH or STATE ever gave RELIEF to the children, until his Wife Regina DIVORCED HIM.

Hulleberg is the low-end of the cartel totem pole and blackmailed by his sexual perversions.

1998 Hulleberg was ACCUSED by the grandmother of his girlfriend's son, of CHILD MOLESTATION. Attorney Jack Ward was able to keep any official charges from being filed.

Although I knew of his family's past abuse, I had not seen him abuse anyone. He even came to our Family Reunion in Red Wing, Minn. People who target others, have few limits to what they will do.

Ward was Hulleberg's attorney before State's Attorney, who was also Hulleberg's neighbor on the old-money street—National Avenue. Hulleberg owned the Old Catholic Bishop's Mansion, with a Sanctuary in the Attic.

No one I knew at the time, saw anything to believe it could be true. We all went to bat for him. No charges were filed. But his stature was not hurt. I see now, how well-concealed these abuse crimes are.

I see how IMPOSIBLE it is for a CHILD to make a Complaint to ANYONE, if the abuse is a parent.

I see how IMPOSIBL it is for WOMEN ACCUSING powerful men, in positions of authority, Church and State, of any sexual crimes BEFORE RECENT TIMES.

2000 Sept. 26 - Dad's Funeral

Hulleberg approached my sister, while she was married with her husband at my Dad's funeral, and wanted her to go to his car for a PRIVATE MESSAGE. She DECLINE. Creepy and now I see as SINISTER.

2012 Church Job's Specialist employs SEX

Hulleberg, being Ward's Proxy was a Financial Big Wig in the Rockford Ward. The Bishop made him the "Job's Specialist." This church "calling" is designed for people out of work, to receive help in finding a employment for their financial needs.

As the local Mormon Church Representative to help members get work and employment, Hulleberg invited my Sister to join his "sex club" and showed a girlfriend dancing nude on a pole.

Hiring someone to perform sex acts, paying them and RECRUITING for these VICTIMS at the local Mormon Church, where Ward's son Brent WAS the Bishop, IS ILLEGAL and called HUMAN TRAFFICKING and PROSTITUTION.

Several other reliable sources, including one of his accountants told me he trafficked a girlfriend to others in some kind of cartel and church "sex swapping club," where one brings a dish to pass.

My Sister called him, as she would expect RESPECTFUL TREATMENT from a family that provided food, shelter and comfort when his Mother Regina passed. Not BJORN!

He invited her first to clean the toilets of his 6-Bedroom Stately Home. Then he invited her to his "Farm." He took her on a path on the side and back of the former full-working farm, with barns, corn-cribs and storehouses.

At the end of the wooded path, was a beautiful wooden, new cabin. Once side had lounge chair furniture, stereo, a fridge, coffee table all open glass, with shades.

The premise of the cabin was to clean it. However, once there, my Sister was invited to another level of darkness. My Sister is not one to exaggerate or make anything up. No history.

As a REPRESENTATIVE of the Church of Jesus Christ of Latter-Day Saints, headquarters in Utah, aka Mormons, OFFERED her a JOB TO MAKE MONEY dancing at "sex parties," where "Only the classy people attend."

Imagine, if you will, in a secluded cabin in the woods, in rural Winnebago County, next house blocks away and

then he shows you photos and video of one of his "gals" pole-dancing

Bishop Brent Ward, after telling him NOT TO RENT to a prospective FEMALE HONEY POT TENANT, instead Ward authorized the installation of a POLE, between the Living and Dining Room, to where I was to be seduced, but declined all flattering invitations. She was beautiful and not of low-morals, but on errand for the cartel. They do what they are told. She and her daughter were victims, too.

My Sister DECLINED the offer to join his "sex clubs" or whatever they call them. Blackmail parties. Hulleberg is on the Board of the Midtown District on 7th St., a Republican Precinct Committeeman, Board of the Mendoholson Club and UNCONFIRMED on the Board of the local "Child Rescue" group.

She told everyone in the family who would listen, about half. The active Mormons in the family believe it is ATTENDANCE which gets one to Heaven.

The Inactive Ones, have been DEFRAUDED by the leaders of the Church. Active Mormons in the family bully the rest of us, never having time to hear a blemish about their CONNECTION TO HEAVEN Via Jack Ward and Apostle Dallin Oaks special handshakes and secret whispers.

I don't believe that and what is being EXPOSED are the secret pedophile networks of the Catholic Dioceses in Chile, Pennsylvania and what's next to be REVEALED are the pedophile networks of political parties and the Mormon Mafia secret society of the Mormon Church.

When I was told, I didn't know what to do. As a newspaperman, I saw PEDOPHILES are protected by past prosecutors, especially when best friends of Jack Ward.

My Sister went to the Bishop or he called her in, and knowing he would deny it and not knowing how to deal with it, since he came to Sunday Night Dinner, plowed the drive when it snowed, gives my Mom a couple hundred

bucks at X-Mass (He gave me a Gift Certificate for a bread store for \$5. It takes \$3 bucks in gas to drive out there.) and got his mail at my Mom's house.

I know now he is posturing, grooming and conniving in ways to steal my mother's house. It's next to Ralston School and wouldn't a pedophile day care be so perfect for the UNKNOWING? I've seen 40 years of patterns and haven't been able to stop them, when they use the court and false witness as TOOLS of FRAUD.

Inviting my Sister to join a "sex club" for money, where only the classiest pillars of the community attend, is STILL HUMAN TRAFFICKING!

And their PEDIGREED is greedy for the children.

Getting a Mother into Human Trafficking is a doorway for the children to be next on the menu. I believe Hulleberg is on the errand of Ward's Cartel in targeting not only my sister, but her children, also.

Ward and the Top Democrat Tom Meyer targeted me at 17, when they acted. How long was I on the menu before they decided to bite? Part of this is Rh Negative Bloodlines, which is in my family.

I just learned Oaks "BLESSED" my nephew!

Ward's father-in-law Oaks was at the Mormon Ceremony giving a "NAME and a BLESSING" to my newborn NEPHEW—my Sister's son, who is targeted by Hulleberg. Now, that I know what Oaks is in the past year, following the money trail, THAT'S CREEPY! He lives in Salt Lake. Comes to town once a month, like clockwork or bagmen.

My Sister's Ex-Husband is a Sheriff's Deputy who works in the CSI Murder Unit Investigation of the Sheriff's Department for the past 20 years.

One of the Grandparents of my nieces & nephews is WROK-Veteran Radio Newsman Fred Speer, who would know

nothing about how his grand-kids are being targeted and WOULD ALSO EXPECT a Grand Jury Investigation.

My Sister also called Jack Ward's Law Firm Reno Zahm, during her divorce and was NOT HELPED at all. She was one of those GOODLY SAINTS that has been approached by the cartel before, and knew this was as DARK AS HELL!

I stayed away from Ward's Law Work, after he got me a fraction of a fair settlement when I was hit by a drunk, broke my leg, 3 months off work, destroyed car, two surgeries. Ward, not a Personal Injury attorney got me \$15K and he took \$40K. I SHOULD HAVE RECIEVED TEN TIMES, that on the low-end. Ward is there fix a poor outcome, when one is not a member of the "clubs."

Hulleberg's Phone Dancer on the pole was his girlfriend, who also worked at Ward's Amcore Bank. She also DID ALL of the Accounting and Book-work of Rockford Development and had a son, allegedly abused by Hulleberg.

I can't say I've seen the son abused. But I've seen Hulleberg's ABUSE in several other ways, and he has assaulted my nephew with choking (grooming) seen by his mother, and another assaulted on a soccer field.

His tantrums and explosive anger, spells a kid that was abused and never got RELIEF. When he was my roommate, I saw the best side of Hulleberg, as he went to work for a bank. I don't know if he was targeting me since 1988 or after Ward commissioned him to later.

When Ward made Hulleberg partner of Rockford Development and his son Brent's William Bradley Dev., Hulleberg became the "face" of the "Limited Liability Corporation." Part of that Limited Liability is FORCING MY MOM to get weekly calls from Rockford Development business, and she is told not to give out that information by Hulleberg.

Another of Hulleberg's Contractors told me of how his girlfriend would complain to him/her of being taken to

bars with strangers and coerced to having sex with them for "practice."

One of the buildings owned by Rockford Development is a "lingerie shop," a front. I don't claim it is their operation, but their are tenants.

I have attempted for years to get a prosecutor to do the right thing. But Rockford has had the Chicago Machine-style politics, which protected the money launderers, like Banker David Kennedy did with the Vatican in the late '50s. Both had "diplomatic immunity." Even Prosecutor Oaks, couldn't have prosecuted them.

Followed the money trail to pedophiles

I've also since discovered in the past couple of years, that PEOPHILE RINGS, like the Catholic Archdioceses, EXIST in the Mormon Church and I've heard numerous stories of the political pedophile rings in Utah and Idaho, like allegedly in Rockford with "touching parties" being run by children of the TOP APOSTLES in the church.

I've heard enough TESTIMONY in 25 years, including TWO sisters, separated by 15 years, with the same "groups" in ROCKFORD, with people involved from the Mormon CONGREGATION, under the influence of Jack Ward's cartel.

What perfect cover? A church and the leadership. See the Testimony of Kristy Allen at the International Tribunal. She claims some of the top Mormon Leaders, like in the Catholic Church, are pedophiles and engage in Satanic Ritual Abuse.

Utah pedophiles hold "TOUCHING PARTIES" according to whistle-blowers, who have documented sexual perversions of the TOP LEADERSHIP of the Mormon Church going back to Brigham Young and his Polygamist perversions he

instituted after he had the Mormon Founder Joseph Smith Assassinated.

5.) Cartel targets half my family Investigate: Why is my family targeted?

Getting me to invest with Meyer took the help of several Mormon Church members, including Bishop Dusek, who was an Alderman with Meyer on City Council, Richard Busker, Ron Lightheart and the PRIME MOVER was Dallin H. Oaks setting it all up from his BUSH-CIA Office at BYU, where his Son-In-Law Jack Ward JUST GRADUATED from J. Ruben Clark Law School.

1978 African-American BAN on Male clergy in the church was LIFTED, that was instituted as a POLICY by RACIST Brigham Young, whose money trail leads to the founders of the Democrat Party and the KKK.

Oaks and Young ARE/were on the Board of Directors of the Union Pacific Railroad, FOUNDERS of the Democrat Party, PRO-Slavery, pro-Human Trafficking, and fought a Civil War to fill E.H. Harriman and Rothschild's banks with enough money to take over the world, which is what they did.

Follow the Money Trail of Young, Oaks, E.H. Harriman, Averell Harriman, Marriner Stoddard Eccles, David M. Kennedy, the Rockefellers, University of Chicago, the INTRODUCTION of HEROIN to America, 1959 and what CIA George H.W. Bush assembled to infiltrate Howard Hughes' military suppliers, with "THE MORMON MAFIA."

Dallin Oaks recruits for the Mormon Mafia online with "The Dallin Oaks Society" at U. of Chicago, and at BYU 1971-1980, when he was fired, for CENSORING Apostle Ezra Taft Benson.

2017 Fall I contacted Kirton McConkie to inform them of an ILLEGAL COCAINE MONEY LAUNDERING banker-bishop Ward.

I was hung up on twice and sent to the wrong Voice-Mail, once. They knew are protecting them.

The son of Law Partner Daniel Stoddard McConkie, Sr. is the First Counselor in the Rockford State Presidency.

When I told Bishop Kris Eschmeyer that I had to put up a blog: rockfordfraud.wordpress.com and a YouTube Channel showing the damages to the properties and the ongoing FRAUDS, he said I had to take that down. I said no.

Bishop Eschmeyer is best friends of Hulleberg and appointed Bishop by Jack Ward. He told me "You have to take it down." I told him he needed to resolve their frauds first. I never heard back. Both Eschmeyer's brothers have been defrauded by Eschmeyer. Brother's keeper?

I made an appointment with the local Mormon Church Stake President Marc Steward. I told his Executive Secretary as much as I could and to look at my blog and YouTube Channel at the ongoing damages.

As I called for HELP!, the stake president canceled the appointment, citing General Conference was that week. I'm BEING DROWNED by church bullies, but the stake president is busy getting instruction from TOP DOWN management and can't hear, nor has time for HEARING my cries for help. Cartel leaders protect pedophiles, frauds, and I'm sure the worst ones are murderers.

Speaking to several attorneys in Colorado, Minneapolis, Idaho and Utah, several sources have told me of PEDOHPILE COMPLAINST SPECIFICALLY levied against Utah Supreme Court Judge and nominated TWICE for U.S. Supreme Court—Dallin H. Oaks.

Oaks was top recruiter for CIA while president of BYU 1971-1980, when he was fired, for censorship Apostle Ezra Taft Benson, whom I met in 1972 at 12 years old.

Oaks and Benson represented the two camps of the church. Racists who follow Brigham Young and those who follow Joseph Smith's version of Mormon Christianity.

1959 The CIA assembled the "Mormon Mafia" to target Howard Hughes companies for infiltration and TAKEOVER. Their power base is Las Vegas, wherein Salt Lake Mormon Bankers financed the mob Casinos at the same time, after they'd been kicked out of Castro's NEW Cuba.

As with "Iran-Contra" proved CIA trafficking ORCHESTRATED by Vice-President George H.W. Bush from the White House called "The Enterprise," no one ever goes to jail. Those convicted were PARDONED by President Bush.

Oaks and Ward who run the Rockford Mormon Mafia are CIA, too and just as protected for 40 years, which includes the cocaine that came to Rockford after the murder of the Two Boys on the Tracks, ordered by Gov. Bill Clinton, Aug. 23, 1987. Three months AFTER the Iran-Contra Hearings, where Oliver North declared, "I was authorized to everything I did."

The drug and child trafficking has been protected for 40 years.

Cast of cartel characters

Mormon Mafia cartel

Dallin H. Oaks is the local mastermind with his CIA history and affiliations.

Jack Ward is the Mormon Mafia King-Pin, who PICKS all of the Priesthood Leaders, from the pool of conflicted partners of their real estate cartel.

Ward's son Brent is an Officer at Chase Bank, a Rockefeller lineage, partners of Harrimans of Union Pacific Railroad, whose Grandpa is a Board Member, but

looks Good Christian Mormons like those in the Rockford congregation he's targeted.

And their "FACE" is Hulleberg, who was a Boy Scout when Jack was the Scoutmaster. Hulleberg's father was an alleged pedophile and his Mother was abused by her brothers. Abuse WAS THEIR FAMILY.

Hulleberg's Mother Regina was a GOOD WOMAN and she divorced to get away from her sick marriage, but she died suddenly of cancer and Hulleberg appears to have been GROOMED by Scoutmaster Ward before she died.

Hulleberg lived with my Parents for a few months before he left on his Mormon Mission to Salt Lake City. When He returned, I invited him to live with me. I thought I taught him Real Estate. He was going to become an attorney at BYU (Ward grooming).

I showed him how to get in on the cheap.

Why would he stab me in the back? Sociopathic is mild.

Democrat Party-City of Rockford

Partners of the City cartel are the Unions, who sire Building Inspectors; Department of Human Services (DHS) employees;

Ward's father-in-law Oaks was a big-wig in the Chicago Democrat Machine in the 1960s. Following the money trail of Oaks & Kennedy, I've discovered a super-secret CARTEL that uses the Mormon Church as "cover," just like the Catholic Church does with child molestation and they began laundering money with this super-secret bankers and CIA operative.

In 1974 the Italian authorities investigated and found the Vatican, Mormon Banker Kennedy and their banking partners LAUNDERING DRUG MONEY for the CIA/Mob, but also printing a \$Billion in counterfeit bonds to fund "Operation Gladio."

Oaks was the BYU RECRUITER for CIA WHO HIRED the LDS Returned Missionary, in "plant" himself inside the Democrat Headquarters at the Watergate Plaza, to leave the door open for Bush's "plumbers" or "burglars," who were NOT sent by POTUS Richard M. Nixon, but a team to FRAMED him for getting America out of Vietnam.

2017 U.S. Attorney John Lausch was just appointed by POTUS Trump, is law partners with Dallin H. Oaks, both from Kirkland & Ellis, CIA contractors, where United Nations Ambassador John Bolton, also comes from.

And Oaks is partners with Mormon Church Law Firm Kirton McConkie, Salt Lake City.

Oaks is also a UTAH SUPREME COURT JUDGE. In my search of an attorney to STOP THEM, I found THREE SEPARATE people who claim Dallin H. Oaks, Vatican Bank partner in the 1960s with David Kennedy, WAS A PEDOPHILE.

Australian Catholic Cardinal George Pell, the LATEST VATICAN BANK TREASURER was just found guilty of PEDOPHILIA.

The same hierarchy of pedophiles EXISTS in the Mormon Church and locally among the Mormon Cartel TARGETING me, my sisters, brothers, Dad and Mom.
